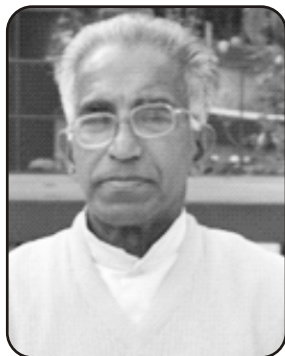


DEVELOPMENT INITIATIVES BY SOCIAL ANIMATION (DISA) ANNUAL REPORT 2016-17

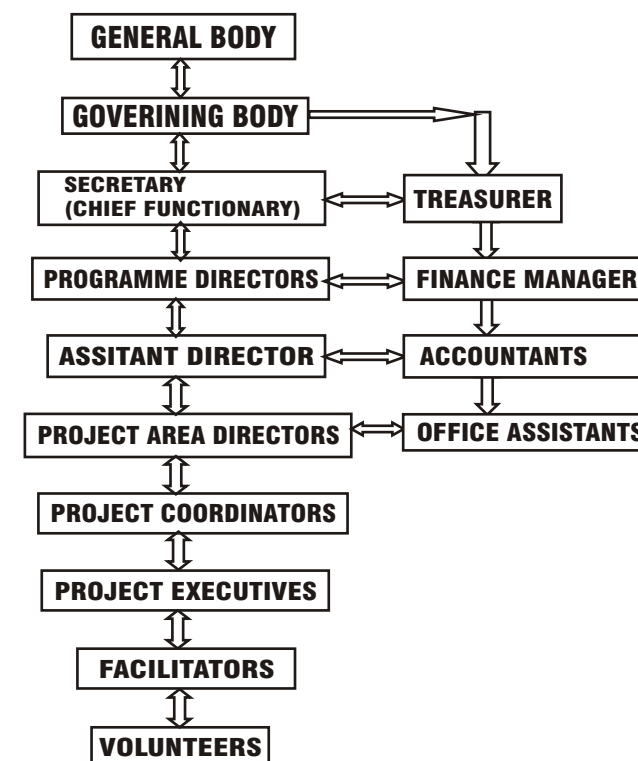

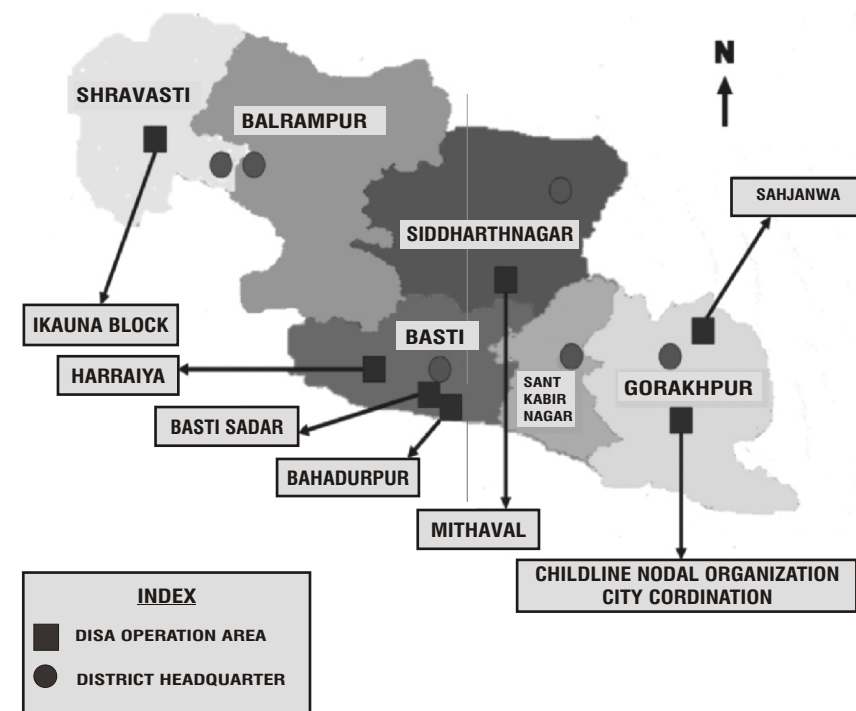

DEVELOPMENT INTERVENTIONS AND ACCOMPLISHMENTS

1. Financial Inclusion and Livelihood Program:

Financial inclusion stands for ensuring access to financial services, timely and adequate credit when needed by vulnerable groups such as weaker sections and low-income groups at an affordable cost. It is often considered as a critical element that makes growth inclusive as access to finance can enable economic agents to make longer term consumption and investment decisions, participate in productive activities, and cope with unexpected short-term shocks. The importance of financial inclusion is that it creates a platform for inculcating the habit to save money, provide formal credit avenues, to plug the gaps and leaks in public subsidies social welfare program. Long years of working with the village women flock have revealed the fact that the key barriers to women's economic empowerment. On the demand side, not surprisingly, rural women have low levels of access to formal finance which coupled with low levels of literacy and numeracy prevent them from achieving their economic potential. On the supply side, financial service providers had not yet developed a solid business case for extending services to savings groups. Even after 70 years of independence, a large section of Indian population still remains unbanked. This malaise has led generations of financial instability and pauperism among the lower income group who do not have access to financial products and services. Hence despite the rapid development and economic expansion, poverty and income inequality remain a determined challenge in India.



All these aspects has been given keen importance and therefore DISA facilitated and mentored the Self-help Groups in the villages for the financial Inclusion economic empowerment in four Blocks. These SHGs have their regular monthly meetings, regular savings, inter-loaning and income generating activities, under the guidance of the staff of DISA. The leaders of these groups shoulder responsibilities for the above mentioned activities. The work and progress in a nutshell is given as follows. The attendance in meetings is 87.65 %. 113 Groups out of 191 are able to conduct the meetings by themselves without the help of facilitators. 53 Groups maintains their records by themselves. 105 new members were learnt to write their own names and put sign. 54 Groups increased their monthly savings from Rs.30 to Rs. 50/60/70 up to 100. 7 Groups have decided to use Cheques for transactions. Trainings were provided for the leaders of SHGs and facilitators on different topics such as Leadership and Micro Planning etc...

Case Study

The success of one group creates seven

Proper funding and timely financial aid can bring even the poor people to the main stream of society. However, usually nobody helps them and if helped, would find it as an opportunity to take away what they already have in the name of huge interest. Here is the example of how Self Help Groups help such helpless women.

Dr. Ambedkar self-help group in Bhanja village of Kaphtangung block is a typical example in this regard. There are 12 women joined in this group. These women deposited Rs. 20 in the beginning as their monthly saving. But in course of time they increased the amount to 30 and at present they are depositing Rs 50 per month. These women received training and with the help of DISA organisation and they were enrolled in National Rural Livelihood Mission. From the mission they got Rs. 15000 in the form of rolling fund and Rs 50,000 in the form of loan.

Husband of the member Sumitra Devi was a skilled worker in carpentry. Sumitra devi proposed in the meeting that she would open a furniture shop if she gets a loan. She got the loan as per the rules and regulations of the group and Sumitra Devi started the furniture shop. The skill of her husband and the quality of his work spread the news about the Self-Help group in the nearby villages too. Not only he became successful but also, he could give employment to 4 more men who are the husbands of members of the group. Sumitra Devi has now started repaying the loan. Success of this Self-Help group gave birth to another 7 more Self Help groups in the village.

2. Gender Justice and Women Empowerment

Despite the fact that women in developing countries provide nearly 70 percent of the agricultural labor, they continue to account for over 60 percent of the world's hungry. Lack of gender equality limits a woman farmer's access to agricultural inputs, credit services and a market to sell her products. These constraints lead to lower crop yields, produce sold at a lower price and, ultimately, continued poverty and hunger for her and her children. Gender-equal access to these agriculture resources could increase the average woman farmer's crop yields by 20-30 percent.

Given the opportunity to generate and control an income, women routinely invest significant portions of their income in food, healthcare and education for their families. Unfortunately, at the moment, the majority of women in developing countries lack economic power, resulting in a higher rate of girls kept out of school, minimal access to basic health care, increased HIV/AIDS prevalence and higher maternal mortality rates. Yet women continue to bear almost all responsibility for meeting the basic needs of the family.



A proven way to overcome many systematic barriers to a woman's success has been increased participation by women in local, regional and national legislation as empowered change agents. In just 10 years, the amount of women holding seats in houses of national parliament in South Asia rose from seven to 18 percent. But a global goal of equal representation is still a long way off, with only one woman for every four men in parliamentary houses.



After long years of working in the field of women empowerment DISA recognizes the national gender imbalance of power and responsibility and empowers women to build their capacity and self-reliance as a way of overcoming obstacles. DISA firmly believes that empowering women to be key change agents is an essential element to achieving the end of hunger and poverty. Women's Leadership Workshops, Women's Empowerment Programms and specialized animator trainings aims to empower women to seek positions of power and train all of our partners, women and men, to take responsibility for improving lives in their communities.

DISA joins hands with NAI DISHA MAHILA SAMITI, a registered society in promoting Gender Justice and Women Empowerment issues. There are 84 Village Level Associations with 1402 members and 30 Gram Panchayat Level Committees having 1402 members. Representatives are elected to form 3 Block Level Women Committees at Basti Sadar, Harraiya and Mithaval Blocks with 815 leaders and they are federated at Central Level to form the *Nai Disha Mahila Samiti*. The Block Level and Central Level Committees have quarterly review and planning meetings whereas the Gram Panchayat Level Committees meet once in two months. Village level Associations have their meetings every month for review and planning for social actions for rights and entitlements. Gram Panchayat level Associations function as broad Community Based Organizations (CBOs). Various collective actions were taken by women to highlight their demands for justice, equity and access to resources. They had many awareness rallies, public meetings, wall writings, common celebrations and cultural programs. They celebrated International Women's Day at Asnar Village in Mithaval Block and had their annual gathering. On the day they focused on the themes on Gender Equity and rights of Girl Children.

Careful Planning, Demonstration at Block, Got Money for Toilet. (Case Study)

In India, it is a herculean task for common man to get the benefit of government schemes. The women of poor families of Kaidholiya Lala Village of Bahadarpur are the perfect example of these difficulties. Authorities underestimated the power of



women and poor to raise their voice against injustice. But they can raise their voice and demand justice if they know about their rights.

Associated with this organisation Nai Disha Mahila Samiti women are regularly making efforts for social development. In the meeting, they realised that toilets were necessary in the village. The women folk of the village, in a group, met the concerned authorities of the block. Seeing that nothing is being done they staged a demonstration. The authorities then understood the seriousness of the issue, especially when the united women became a force, then they have allotted money to 22 families to build toilets. Same result occurred in many other villages. People are now using the toilets. The women are also happy and felt secured with the new strength they got by joining Nai Disha Mahila Samiti.

Dealer Suspended, Ration Distribution System Rectified (Case Study)

The poor of the village largely depend the public distribution system like ration shop where they will get the food grain cheaply. But they are exploited by the ration dealers by not giving them proper quantity of grain. Most often these dealers sell the grain in open market and make huge profit.



A ration dealer from Rajswa village of Lahauria, Tilakpur gram Panchayat, Vikashkhanda Kaptangunj, was not distributing ration to the people on a regular basis. If distributed, he unnecessarily charged excess amount from the people. Besides this, he also maintained a false record in the card even for those months in which no ration was distributed to the people.

Getting fed up with this sort of unfair work, the women lodged a complaint against him to BDO and other officers too. But nothing happened. Finally, the women moved to DM with the complaint. The DM took it seriously and began investigation. In the investigation, the dealer was found to be guilty. He got suspended and the job was offered to some other person. Now the women as well as the people living in the village are getting ration timely.

Women Showed Courage, Brick Road constructed (Case Study)

The roads, especially in the interior villages of India, are a pitiful sight to see. Here is an example of 'If there is a will, there is a way'.

Nai Disha Mahila Samiti was formed under the guidance of DISA organisation in a village of Kaphtangunj Block. There are 84 women members associated with this. They raised the issue of the pathetic condition of the alley starting from the house of Jhanmati up to the house of Ramapati in the meeting organised by Nai Disha Mahila Samiti.

This alley is filled with water in rainy season, children going along this path are slipped and get injured, and even it is much difficult for the grownup to walk along. After the discussion the women decided to contact the village Pradhan to get the road brick laid.

The responsibility to meet the pradhan was given to Sumitra Devi and Rajkumari who are the office bearers of the organisation. But the village Pradhan, as usual to any such demand, showed the least interest.

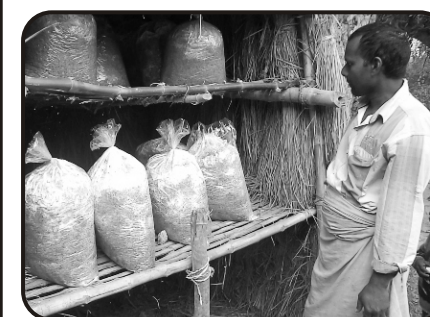
One day during the rainy season women of the area got together went to his house and showed the pitiful condition of the road. Seeing the collective force of the women the Village Pradhan agreed to construct a brick laid path. After ten days when the rain got over, construction work started and the women themselves worked under MNREGA. The villagers praised the women for their wonderful work.

3. Sustainable Agriculture and Natural Resource Management

For any country, the basic component that decides its growth, is its economy. In India's case, that base is agriculture. Agriculture plays a very important role in all the major economical sectors of India and is one of the most crucial factor in the country's development. Agriculture is considered the backbone of Indian economy. Despite the fact that in the last 6 decades of planned development era since India became a Republic, a tremendous success India has achieved in the field of industries, agriculture and allied activities of agriculture still continues to provide employment to around 65 per cent of the total workforce. Agriculture and allied activities make the single largest contribution to GDP (Gross Domestic Product), accounting for almost 27 per cent of the total.



We have a plan to meet these challenges through sustainable agriculture and natural resource management. The questions we face while trying to implement a sustainable agricultural practice are, how to meet these challenges while protecting nature, helping people in rural communities live better lives, and satisfying consumers who demand greater variety, quality and quantity of food? A generally agreed fact is that one of the



next decade's biggest challenge will be producing enough food for a growing population. Yet we are clueless and are confused about the solutions. Many advanced technologies have been manifested with the aim to minimize the use of pesticides, fertilizers and genetically modified seeds and to meet the future requirements. Promotion of best agricultural practices for better and more profitable land use, increasing the livelihood and income sources and protection of natural resources have been the focus of DISA.

Kisan Club 'inspired' new Ways of Farming (Case Study)

Most of our farmers follow the traditional and conventional methods of farming. Most of the farmers are illiterate and not aware of new methods of farming. If they are properly guided they can produce more, earn more and the nation can prosper more.

Ram Piyare, a farmer of Damodarpur village of Bahadarpur block was benefitted from the awareness programme of Samriddhi Kissan club.

He converted his traditional farming to mixed farming. Mr. Ram Piyare has become an inspiration for everyone with the cultivation of 'Shri Biddhi' paddy. Besides paddy he started cultivating bananas and different varieties of vegetables in his land utilizing the land in a better way. He not only gets vegetables for the need of his family but also to sell and earn some money. He also inspires other farmers in the club to cultivate fruits and vegetables. He got a prize from the block Pramukh for being a good farmer. At present he has become an ideal example for all the farmers in his as well as nearby villages. Ram Piyare gives all the credit to DISA organisation.



4. Community Based Rehabilitation and Empowerment of PWDs



Persons with disability are the most disadvantaged section of society, they are also neglected in their family. Rehabilitation of people with disabilities is a process aimed at enabling them to reach and maintain their optimal physical, sensory, intellectual, psychological and social functional levels. Disability refers to the disadvantage or restriction of activity caused by the way society is organized which takes little or no account of people who have physical, sensory or mental impairments.

As a result such people are excluded and prevented from participating fully on equal terms in mainstream society. Rehabilitation provides disabled people with the tools they need to attain independence and self-determination. Even though the constitution

guarantees equality freedom and dignity to all individuals, including persons with disabilities. But besides these policy frame works, we have to make things work. One of key instrument is education. Children with disabilities should have access, from the very beginning of their school lives, to the best possible educational opportunities that will enable them to cope with their disability and overcome any lack of self-confidence. Community Based Rehabilitation (CBR) is a strategy within community development for the rehabilitation, equalization of opportunities and social integration of all people with disabilities. CBR is implemented through the combined efforts of disabled people themselves, their families and communities, and the appropriate health, education, vocational and social services. Our efforts to reach out to the most vulnerable and excluded section in the society have resulted in focusing on children and *People with Disabilities* (PWDs) for their rehabilitation and empowerment. 73 Children have been directly assisted for their social, educational and medical fitness. 14 children are admitted in St. Francis School for Hearing impaired, Lucknow and 04 children are admitted in *NavJyoti* School for Visually Impaired, Lucknow. Others are pursuing their studies at local schools. The annual gathering of these children along with their guardians was conducted on 21 June at Harraiya and on 20 June at Kalwari and 28 children got special prizes in the various competitions conducted. 38 children participated in the gathering in Gorakhpur on the World Disability Day (UDAAN XII) organized by PGSS and Diocese of Gorakhpur. We initiated our efforts to form Disabled Persons Organizations (DPOs) to demand and get the due rights of the PWDs. We organized awareness programs through Puppetry and trainings in view of forming DPOs and Inclusive SHGs. Our target is to form 35 DPOs and reach out to more PWDs. (28 DPOs are formed in 2016-17)

Disability is a State of Mind (Success Story)

It takes courage for any ordinary man to achieve a feat like success when he lacks at something; it simply requires passion for a person with disability to level the fame. Raj Tiwari (11 son of Mr. Ram Sagar and Mrs. Krishanawati from Phardapor village, Harraiya Basti Dt. U.P, stands as the epitome of unbeatable confidence when this disabled child (Loco Motor) achieved the feat of becoming first in the Navodaya Test from Harraiya Blcok.



Raj belongs to a financially back ward family and the sole income generation comes through farming in the scanty farmland owned by the family and through the selling of vegetables from the same. His mother is also an active member in the Self-help Group and she used to be present in every meetings. During the meeting the Coordinator, Sr. Lilly mentioned about causes and prevention of disabilities and she came to know about Raj during the meeting. Then Sr. Lilly took some time to give awareness to the parents of Raj regarding the importance of education. And later

2010 he added to the JVS/CBR program. When he joined with JVs program he was only five years old and was not going to school. Through the intervention of the DISA he started to go to the school and now he is studying in class 7th.

Raj has improved his health and attitude and interested in doing his daily activities by himself. Our first intervention was to do the ADL by himself and at first he started eating by his own hand, he takes bath by himself and he also helps the family members in the household activities. He respects his parents and others in the village there by creating a good environment in the neighborhood.

In his the family all respects him and cooperate with him to do his daily activities and responsibilities. He uses bicycle to move around in the village and neighborhood. He has gained a name and fame in the community by coming first for the Navodaya test from Harraiya Block. The significant change that we could see in him is his excessive desire to do his studies well, his rapport with others and his will power to do his responsibilities well is outstanding. He is very good in mathematics. The family members as well as the society are very grateful to JVS and DISA for enabling Raj to grow in skills and knowledge and have come up in life. He now nurtures the feeling of equality with others. And they continue to believe that through the continuous effort and help of DISA Raj may be able to shine in the future.

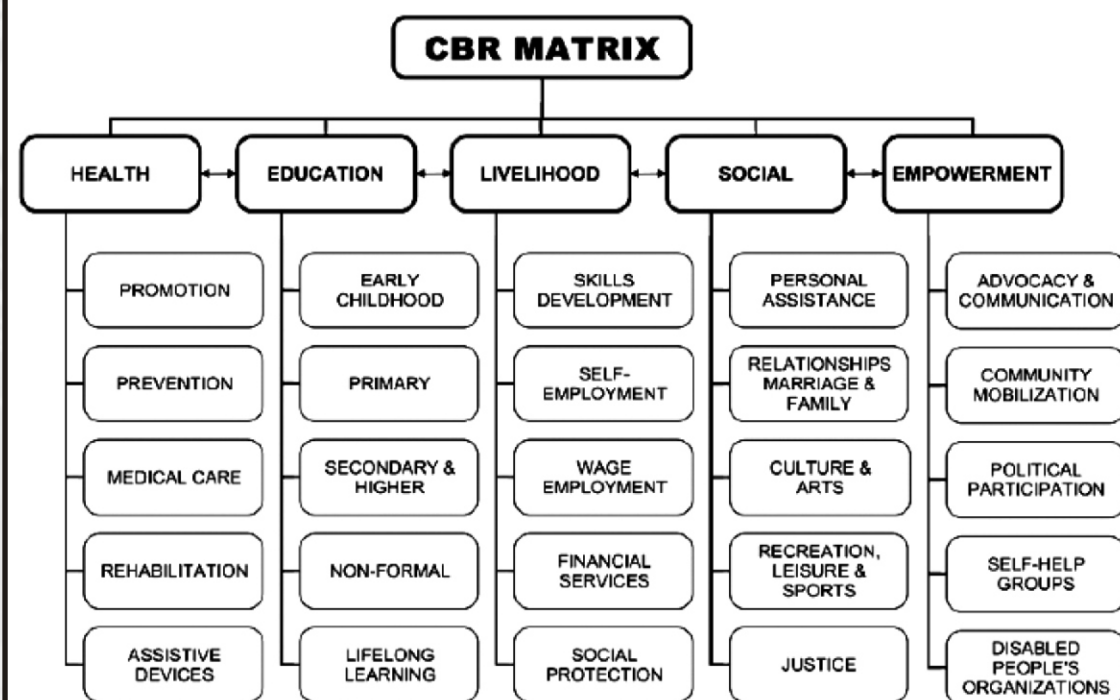
Success Story

The success story of Akash is none different than the above. He still fights the odds to proclaim the will power of the human being to aim high neglecting the physical disabilities. Akash Kumar (17) is the son of Mr. Aravind and Ms. Pamela. They live in Bhairampur village, Bahadurpur, Basti Dt. U.P. He has got two brothers and one sister. He is the eldest in the family. Economic backwardness has been the hard nut to crack issue that this family faced and still this continues to be the current state of affairs. But nevertheless his whole family supports him to carry out his daily activities.

The first contact with Akash took place in the Year 2009. DISA is having the community development program in his village and his mother is an active member in the Self Help Group. She used to be present in all the meetings. During the group meeting Fr. Francis, the then director had a discussion with the members regarding the causes and prevention of disabilities. Pamela informed Fr. Francis about Akash and his disability and he visited him at home. Later in the year 2007 he was admitted in the JVS/CBR program. When he joined with the program he was only six years old and was not going to school. Through the intervention of DISA he started to go to the school and now he is studying in class 10th. The mediator of DISA felt the need of providing him with the wheel chair and the crutches. It helped Akash in his day to day life. With the help of DISA he managed to get the Disability certificate. The organization helped him to get his wheel chair and pay his school fees. Now Akash has improved his interest in doing his studies and daily activities. He hold the remarkable position of 2nd rank in his school. Through our intervention he became very active, does all the works at home and out. He respects his parents and others in the

family and outside. He has created a good relationship in the community. In the family all respect him and cooperates with him to do his daily activities and responsibilities. He uses Tri-cycle to move around in the neighborhood. Some times without any aid he is able to move around in the house. He has gained name and fame in the community through the showcasing of his will power to fight the negativities of physical disabilities. The significant change that we could see in him is his great desire to do his studies well, his friendship with others and his will power to do his responsibilities well. Now he has joined with livelihood program. The family members as well as the society are very grateful to DISA for enabling Akash come up in life. And they continue to believe that through the continuous effort and help of JVS and DISA Akash may be able to have a better future. His parents also have given confidence that he can do the wonderful works. He is able to continue his studies as well as run the petty shop with his parent's support.

5. Skill Development for Youth

DISA's Skill development trainings are driven by the core belief that everyone has potential and ability but due to adverse circumstances, women in the informal sector are sometimes not able to achieve their goals. Our training programmes are a collective approach to overall development of women and our capacity building programmes cut across all the requirements.



Our training programmes help to develop women's self-esteem, confidence and leadership skills. Local women leaders understand the power of collective struggle and organize to take the DISA movement forward. Trainings help women build their capacity, both technical as well as managerial. They also discuss the importance of women workers in society and the struggle for equality. These training programmes help raise the women's awareness levels. They also learn to share information and experiences and develop a sense of pride in themselves and their organization.

Given the illiteracy level in India and amongst our members, all our training methods are based on interactive approaches. The participants are involved from the very beginning in the training through activities like role-play, discussions, exercises, drawings, songs and games. We believe in "learning by doing" and this philosophy guides the classes and field exposures.

Our capacity building programmes can be categorized as leadership, technical, exposure and dialogue and other training programmes. DISA took steps to impart skills to enhance their employability of the youth. Trainings were given 713 beneficiaries mostly teenage girls in Garment Making in DISA Harraiya with the support of Little Flower Society, Germany. Many of the trained youth are having their practices at home or in their own villages, whereas 20 persons have gone outside for work in different companies for their work.

The Facilitators were given special trainings on community based impact and various technical aspects, training on Systemic Change, Motivation and Leadership Issues.

PARTNERSHIP PROGRAMS

DISA is Partner for the implementation of the following Programs

1. ECO-DRR Program (Eco System Based Disaster Risk Reduction)

The ECO DRR Project is being implemented in 12 Villages Block of Ikauna Block, Shravasti District from September 2015 by DISA through the support of Caritas India, New Delhi. Shravasti District is one of the districts of the Uttar Pradesh, India and Bhinga town is the districts headquarter. Shravasti is a part of Devipatan Division is located near River Rapti. Natural disasters that are common in Uttar Pradesh are –

Floods, Droughts, Fires and Earthquakes. Loss of life and property from these disasters, especially the former three, are in terms of hundreds of corers of rupees annually. UP is also vulnerable from the aspect of man-made hazards too i.e. stampede, chemical, radiological and other hazard.



Approximately 7.34 million hectares of area get affected annually due to Floods. Annual approximate loss due to floods is Rs. 432 corers. Number of human loss due to floods & thunder storm is 380 in the year 2013. As per the 2014 report, 68,000 people had been hit by the floods in Shravasti district. The important area of concern in the district Shravasti is that it is badly affected by frequent floods every year. The water from the River Rapti in the rainy season submerge many of

villages and destroy households, crops, roads, trees, electric poles and many other public infrastructures.

The main goal of this Project is to restore the Eco-System by adopting Eco-based Disaster Risk Reduction and Climate Sensitive Practices with focus on community institutions, resilience building, networking and convergence for their Rights and Entitlements (Eco-DRR) with the support and guidance of CARITAS India, New Delhi.



Case Study

Ever since the implementation of ECO DRR project in Jodhpur Village, the village has been experiencing ripples of societal transformations through the interventions of the ECO DRR staffs, in all the aspects of their lives. Since the village is close by the river Rapti annual floods have shattered many lives of the villagers. During the raining season finding a suitable means for cooking food was difficult for the villagers and the programme has helped many villagers to make use of the government scheme for obtaining gas connections. Below given is the example of successful materialisation of the ECO DRR project in one among the areas of its focus.

Gudiya Devi lives in village Jodhpur and belonging to SC community. She always participates in community meeting (ECO DRR Project). In the beginning stages of the project she was bit critical about the project but when she understood through gradual participation of the meeting, the benefits of this project, she started encouraging her neighbours to join the group. It was in one such meeting that the villagers came to know about the Pradhan Mantari Gas Ujala Yojana. Through the support of ECO DRR project

eligible families met the associated officer and they received the benefits. After one month 12 families have received free Gas connection in Jodhpur and Gudiya Devi is one among them. They have now become convinced of the importance of having information about the different government schemes which otherwise remains hidden and manipulated. The villagers are very grateful to the facilitators and staff of the ECO DRR project and DISA for enhancing and empowering their lives.



2. Sujalam Sufalam Initiatives- GDS Network

The Project envisages the social and economic empowerment of the small and marginal farmers especially strengthening of 1000 marginal Farmers to improve their livelihood so as to enable them to get Rs. 50,000/- as additional income in three years with the support of Sir Dorabji Tata Trust through the able guidance and support of GDS Lucknow. We do accompany and mentor the Small and Marginal Farmers to improve the farming, use of new technologies to enhance economy. Motivating the Farmers to adopt Agriculture Cycle, new intensive crop pattern, reduced use of chemical fertilizers and pesticides, promotion of organic farming, preparation of compost and organic pesticides, SRI method of paddy cultivation, tree plantation, soil testing etc.. Facilitating to get NABARD and Govt. support and entitlements etc.

Case Study



Ashirun Nisha wife of Mohd. Aleem is a permanent resident of village Bhawpur of Mithwal Block of Siddharthnagar District. She is a small farmer with a land holding of 0.83 Acre and with a yearly income of below INR 20,000 only. Her husband is migrated to Mumbai due to poor financial condition of the family and for some extra income generation.

She was shortlisted under Tata & GDS supported programme Sujalam Sufalam by DISA for the enhancement income through technical farming in

the year 2015. In past years the land was only used for paddy and wheat cultivation which gives them very minimum profit margin in a year. With the support of DISA she learns about crop cycle and other suitable crops for her land. She replaced Wheat with Gram in Rabi Season and earned much better profits than wheat as the price of Gram was around INR 100 to INR 110 per Kg. whereas the price of wheat was INR 14 per Kg. While sharing her experience on Gram farming she told that, Gram was cultivated in that area around 15 years back and it was very successful crop in those days but in recent years it was a failure as there were so many diseases (wilt) and insect (pod borer).

Because of these problems there was a negative impact on the crop and people were stopped cultivating it. She adds it's because the farmers in those areas are unaware about the seed and soil treatment through Trichoderma. DISA follows a very specific package of practice for each crop and it is promoted by the organization for maximize the output for each crop. Seed treatment, soil treatment and line showing are the basic and minimum practice followed under any crop intervention by DISA.

She cultivated Gram in 0.25 acre and got around	140 Kg

She became convinced of the new farming technique and has expressed her deep conviction about increasing the area of Gram cultivation up to 0.5 acre from next year. She also had preserved the seed for next year. She is very grateful to GDS, Tata Trust and DISA team for the technical imputes and timely support and guidance all throughout the year. We hope that the very example of Ms. Ashirun Nisha will encourage many other small and marginal farmers to practice the basic package of practices (POP) and seed treatment for the better cultivation of crops and increase their incremental income year by year.



3. Systemic Change Program



The principle of systemic change, in the context of works among the poor, looks beyond providing food, clothing and shelter. Its particular focus is on assisting the needy to change structures in which they live and on helping them develop strategies by which they can emerge from poverty."Systemic change" goes beyond that and focuses on the whole system. Put differently, systematic change describes a process: a way of bringing about a result. In contrast, systemic change is a result in

which a complete series of interacting elements are transformed.

The Program envisages the social and economic empowerment of the Dalits, Women and the marginal Farmers in the selected 67 villages spread out in 46 Gram Panchayats of Basti Sadar Block through the idea of Systemic change. With the support of with the support of SCN Ministry Fund, U.S.A. we do the mentoring and empowerment of the excluded People in the selected villages of Basti Sadar Block in Basti District for

Systemic Changes through the formation of CBOs and right based approach. These villages have a sizable population of excluded sections viz the Dalits, Muslims, Disabled and economically weaker sections. The majority of them are having very low educational status and hence largely unemployable, particularly the women, living below poverty line. Many of the youth adopt migration to other cities in search of livelihood. It is largely agricultural belt with good possibility for agro based activities for livelihood and economic progress. The communities are plagued with caste and class based discriminations, cultural and gender barriers and are blocked from getting their due share in the society. Lack of awareness and poor associational strength of these excluded continue to keep them exploited, which necessitates our accompaniment and mentoring for rights and entitlements. The purpose of the project is to mainstream the poor and the excluded and empower them socially and financially.



Our interventions with the support from *SCN Ministry Funding Network* benefited about 868 families of SHG members, 1260 women who are members of the *Nai Disha Mahila Samiti* and 468 farmers of the Farmers Clubs. The total population in the selected area of 46 Gram Panchayats is 1,96,225 in which, 44,391 are of Scheduled Castes (Dalits), 99,073 are of Backward Castes and 52,761 are of the General category.

Case Studies

Wonder of Milk made the woman happy and prosperous (milk to money)

It is likely for every woman to dream of a prosperous family life. However, she lives this prosperous life only in her dreams due to the massive poverty and unemployment. Even when they are ready to work it is hard to find any generous hearts who would employ them.

Roshni self-help group formed in village Narayanpur of Bahadarpur block in 2016 has brought about a drastic change in the lives of the people there. there are 14 women members in the group each depositing Rs 100 towards saving. Mrs. Sunanda Devi, wife of Ramlout is a member of this group. She earned her living from the little amount she got from daily wages.

It was her dream to rear a buffalo because she saw many nearby families leading prosperous lives by selling the milk and calves. But poverty and other difficulties never allowed her to find enough money to buy one. At the time of discussion in the group, she expressed her desire to take loan from the group and buy a buffalo. The dream was materialized when the group decided to give her a loan of Rs 5000. In the course of time, the buffalo she purchased started giving milk and she could repay the loan. At present she owns many buffaloes and she sells all milk products. She is proud to contribute to

the income of the family and has the satisfaction of leading a prosperous life like many other families.

Multiple ventures with the help of Self Help Groups

Self- help groups run under the guidance of DISA are given directions on income generating methods in their monthly meeting. Women associated with this group got ideas how they can start creative income generating work and many came forward and became fine example for others.

Mrs vidhyavati Devi member of Bhais Barha of Basti Sadar Block took loan of 15000 to open medical store for her son.

Mrs. Soharata Devi of MahaLaxmi Self Help Group took loan of 15000 to open shoes shop for her son.

Mrs. Indravati Devi of Azad Self Help Group, Kadauva ghat took loan of 15000 to open shoes shop for her son.

Mrs. Ram Dulari of Aradhana Self Help Group, Kurhapatti, took loan of 10,000 to open a Cosmetics shop.

Mrs. Tarabunnish of Mohammad Self Help Group, Baksar took loan of 5000 to invest in her husband's tailoring shop.

Mrs. Kailashi of Chandni Self Help Group, Khadauva Khurd took loan of 5000 to open vegetable shop.

Mrs. Savitri of Sheetal Self Help Group, Ramvapur took loan of 5000 to buy new machine for her daughter's Tailoring shop.

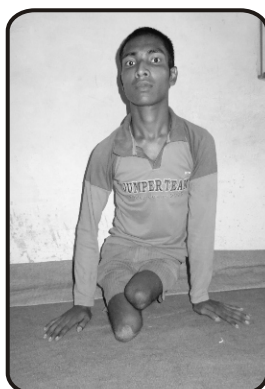
Mrs. Urmila of Jaymatha Self Help Group, Katri took loan of 10,000 to open small scale grocery shop.

Mrs. Dashradha and Sunita Devi of Sarvesh Self Help Group, Dudhaura took loan of 5000 to open vegetable shop.

4. JVS/CBR Program

The Liliane Foundation contributes to a world that is open for everyone, and in which children and youngsters with disabilities who live in poverty can develop and use their talents. Together with local organisations in Africa, Asia and Latin America, they make children stronger and their environment more accessible and DISA is one of the Partners to accomplish their goals through support of Jan Vikas Samti, Varanasti. We are involved in the rehabilitation of 73 Differently Able children by adopting them for integrated development for which *Stichting Lilliane* Foundation has





extended support through Jan Vikas Samiti, Varanasi. We follow the principles and practices of Community Based Rehabilitation (CBR) model. The children adopted are given medical, educational, social and emotional support to cope with their disabilities and integrate themselves in the mainstream of the society. 14 children are in St. Francis School for Hearing impaired, Takurganj, Lucknow, 4 Children in Nav Jyoti School for Visually Impaired, Mohanlalganj, Lucknow and *Jeevan Dhara*, Kasia. Together with Liliane Foundation we also try to contribute to a world that is open for everyone, and in which children and youngsters with disabilities who live in poverty can develop and use their talents.

5. CBR Program

CBR may be defined, according to three United Nation Agencies, ILO, UNESCO, and the WHO, as a “strategy within community development for the rehabilitation, equalization of opportunities, and social integration of all people with disabilities. CBR is implemented through the combined efforts of disabled people themselves, their families and communities, and the appropriate health, education, vocational and social services” (WHO, 1994) It differs from Independent Living in that, according to Lysack (1994), the entire community is the target of CBR programs; the CBR model is one of community development or partnership; IL ideology places control squarely with disabled consumers.



DISA has initiated a new program with the support of CBR Forum, Bangalore in the month of April 2016 for the empowerment and inclusion of persons with disabilities in Shajanwa Block, Gorakhpur, U.P. through the Community Based Rehabilitation (CBR) Program. The overall impact of the program will be that the people in the community especially those with disability are considered as equal members of the community and have space and opportunities to realize their potentialities. For the

CBR program DISA has recruited five CBR workers including coordinator and they have been given special training on CBR, PWD Act, types & identification of disability

and prevention etc...Under this program we are covering 35 village 17 Gram Panchayaths and identified 440 CwDs/PwDs during our survey. We will be focusing on the five CBR component i.e Health, Education, Livelihood, Social and Empowerment through the formation of VDPOs and BDPOS (Village level and Block level Disable persons organization).

Case Study

CBR Programme was introduced in the Sahajanwa Tehsil of Gorakhpur. The initial survey had shown that the number of disabled people around the locality was more than the given data obtained from the Government. Ajeeth (13) son of Mr. Krishn Mohan and Mrs. Meera was included in the beneficiaries list of the CBR programme and since 2016. He is a mentally retarded child lives with his parents. He has two younger brothers- Amit and Sangam. Amit studies in class 3rd. His father works in a private mill at Sahjanwa.

During the interactions by the facilitators with the parents of Ajeet, it was told to them that the child did not behave normal after his Birth. After 15 days his parents had taken him for a medical checkup to a child specialist in Gorakhpur. But they didn't get any satisfying response from the doctor. Continuously for six years his parents had been giving the same outdated medicines for Ajeet but it was of no avail and did not show improvement. So his parents lost hope in the medicine and stopped the medicine.

The financial constrains had made the father of this child to leave the fate to the hands of destiny. Since he also has to support his family with the meager income that he gets by helping in the nearby rice mill, he found it all the more difficult to attend to the medical needs. Regular interventions by the facilitators and coordinators have made lots of difference in this child's life. The attitude of his father and mother has changed and now all the family members are always at the beck and call of this child. At present he gets regular medication and even though he is not able to walk because of the physical inability caused by the disease his mother takes care of him well. The parents are grateful to the interventions made by the CBR staff and DISA in the life of their child who otherwise would have been living a total neglected inhuman life.

6. CHILDLINE City Coordination

In 1996, CHILDLINE India Foundation (CIF) launched CHILDLINE, the country's first toll-free tele-helpline for street children in distress. As of March 2015, total of 36 Million calls since inception have been serviced by CHILDLINE service and operates in 366 cities/districts in 34



States/UTs through its network of over **700** partner organisations across India and DISA is one among them to fight for the rights of children Gorakhpur.

Today, throughout the world, around 250 million children work, many full-time. They do not go to school and have little or no time to play. Many do not receive proper nutrition or care. They are denied the chance to be children. More than half of them are exposed to the worst forms of child labour such as work in hazardous environments, slavery, or other forms of forced labour, illicit activities including drug trafficking and prostitution, as well as in armed conflict. Despite the efforts taken by governments and other voluntary organizations, in developing countries, with high poverty and poor schooling opportunities, child labour is still prevalent. India is home to around 13 million child labours according to the census statistics.

DISA is the Nodal Organization of CHILDLINE, Gorakhpur since January 2006. We join with PGSS, Gorakhpur, the Collaborative Organization to manage the city coordination for the rescue, rehabilitation and other operational aspects of CHILDLINE program. This year CHILDLINE, Gorakhpur has attended.

COMMON CELEBRATIONS OF DISA

DISA also celebrate the following common National and International Days with the CBOs and community members

Go to School Campaign and Seminar [“School chalo abhiyan”]

Even though Literacy rate in Uttar Pradesh has seen upward trend and is 67.68 percent as per 2011 population census, of that, male literacy stands at 77.28 percent while female literacy is at 57.18 percent, it raises several issues. The tope in the table of issues caused by illiteracy is increase in child labour and exploitation of the weaker sections by the so called elite educated mass. Though Education is made as a fundamental right by Indian government, neither the children nor their parents take any kind of interest about schooling and the children are seen engaged in household activities or playing around. Education is proven as the key for socio economic changes and unless we give priority to it, all our efforts will go in vain.



Keeping this in mind, an awareness campaign was conducted titled ‘Go to School’ under the guidance of DISA organization in Basti city, Haraiya and in the Mithawal block of Bansi. The mission was to make the parents and children aware of education. The rally was held by the teachers and students at 31 schools of the three blocks in order to provide the perception on importance of education. A seminar was held after the rally and the residents of villages were greatly inspired by the programs conducted so that they decided to enroll their children in the nearby schools. Besides a total of 765 children volunteers of DISA also participated in the rally.

Safe Motherhood Day

National Safe Motherhood Day is observed on April 11 every year. National Safe Motherhood Day 2016 is an initiative of the White Ribbon Alliance India, to enforce that women must have the availability and adequate access to care during pregnancy, childbirth and postnatal services. The goal of observing safe motherhood day is to educate women and help them realize their rights to be safe and healthy before, during and after childbirth. Our mission is to inspire, encourage and assist the advocates of campaigns that help in upholding the rights of women to be safe during the child-bearing age and through the child birth process.

This campaign was also held in Basti Sadar, Harriya and Mithwal blocks under the guidance of DISA organization in the month of April. Members of ‘Asha’, ‘Anganwadi Worker’ and ‘ANM’ were also participated in the rally. Detailed information regarding before, after and during delivery were provided in the seminar. A total of 26 rallies and 13 seminars were conducted in all the three blocks in which 313 pregnant women have participated.

International Women's Health Day

May 28 is the International Day of Action for Women's Health, which for over 30 years, women's rights advocates and allies in the sexual and reproductive health and rights (SRHR) movement worldwide have commemorated in diverse ways. Year after year, women, girls, advocates and allies have continued to take action and stand up for sexual and reproductive rights for what they are: an indivisible and inalienable part of our human rights.

Now, at a time when women's human rights, and particularly sexual and reproductive rights continue to be systematically violated worldwide, mobilization both within and beyond our communities remains essential, in order to resist any rollback on our rights and advance sexual and reproductive justice for all. As the global geo-political context threatens to become increasingly regressive, it is more important than ever to denounce any attempts at curtailing women's rights, including our human rights to decide freely upon all aspects of our bodies, our sexualities, and our lives, free from coercion, discrimination and violence.



The rally and seminar on World Women's Health Day were organized in Basti Sadar, Hariya and Mithwal blocks with the co-operation and guidance of DISA Organization. Information regarding the health, sexual and reproductive rights and sanitation have been provided in the above mentioned gatherings. Volunteers of the organization conducted the program at all three centers as per scheduled. 24 rallies and 32 seminars were conducted in these issues in which a total of

479 women including expectants were also participated.

World Environment Day

The United Nations, aware that the protection and improvement of the human environment is a major issue, which affects the well-being of peoples and economic development throughout the world, designated 5 June as the World Environment Day. The celebration of this day provides us with an opportunity to broaden the basis for an enlightened opinion and responsible conduct by individuals, enterprises and communities in preserving and enhancing the environment. Since it began in 1974, it has grown to become a global platform for public outreach that is widely celebrated all over the world.

The people in villages can do much if given awareness regarding the dangers of polluted environment and the importance of environment protection. Awareness programs were conducted by the volunteers of DISA regarding environment Day at Basti Sadar, Harraiya, Mithaval and Ikauna Blocks.

In a nutshell, under the guidance of DISA a total of 27 seminars were conducted in which 1983 people has taken the resolution of afforestation in the month of June.

The members of 'SHG Kisan club', 'Nai Disha Mahila Samiti' and 'Saloni Sangam' were inspired by the campaign and planted 2314 saplings of mango, *Sagwan* [teak], Eucalyptus, Banana, Jack fruit etc. at all three centres of Basti city, Harraiya and Mithwal blocks.

World Breast Feeding Week

World Breast feeding Week is held annually between the 1st – 7th of August to encourage breast feeding and improve the health of babies around the world. Over 120 countries across the world get involved in the celebration, and this years focus falls on breast feeding in relation to sustainability.

Breast feeding is the best way to give newborns the nutrients they need. Breast milk is highly nutritious with easy-to-digest proteins and natural immunities that protect babies against disease and infection. Colostrum, the milk that mothers produce in the first days after birth, is not only dense in nutrients, but is also rich in antibodies that protect babies from bacteria and viruses that cause infection.

With the help of DISA a seminar and wall writings for spreading awareness about the importance of breast feeding was carried out in Ikauna, Harraiya, Basti Sadar and Mithwal block. 'Asha', 'Anganwad Worker' and 'ANM' also volunteered in the rally. Besides these, the doctors and health assistants of Primary Health centres were also invited. Rally started with the signaling of green flag, followed by a seminar in which the people were given awareness about the importance and benefits of breast feeding. Overall 29 rallies, 27 seminars and 750 wall wrtings were carried out in the three blocks.

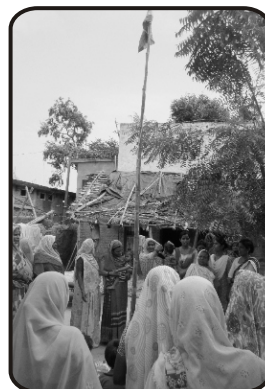
Independence Day

Every year August 15th is observed as Independence day in remembrance of the nation's independence from British empire in 1947 on the same day. Despite of class, religion,



creed or race India celebrates Independence Day as national festival. Independence Day is a day when people in India pay homage to their leaders and those who fought for India's freedom in the past.

Usually Independence Day celebrations are confined to cities and towns and villages are neglected. It was decided to celebrate this year's Independence day along with the villagers. The director of DISA went to the villages and hoisted the national flag. The volunteers of DISA organization reminded the villagers struggles and sacrifices made by our leaders and freedom fighters. In a nutshell, in 123 villages, in all the three blocks, DISA along with the villagers, celebrated this great day in the history of India.



International Literacy Day

International Literacy Day, celebrated annually on 8 September, is an opportunity for Governments, civil society and stakeholders to highlight improvements in world literacy rates, and reflect on the world's remaining literacy challenges. The issue of literacy is a key component of the UN's Sustainable Development Goals and the UN's 2030 Agenda for Sustainable Development.

This year marks the 50th anniversary of International Literacy Day and UNESCO is celebrating it under the banner "Reading the Past, Writing the Future". International Literacy Day 2016 celebrates and honours the past five decades of national and international engagement, efforts and progress made to increase literacy rates around the world. It also addresses current challenges and looks to innovative solutions to further boost literacy in the future.

The volunteers of DISA conducted a Literacy day campaign in Basti, Harraiya, Ikuna and Mithwal blocks. The campaign aimed at teaching the members to write their names and put their signature. The importance of these was also explained to them. Being motivated, the entire members attended, learnt to write their names. The members who learnt first were given incentives. In total 105 members learned to write their names and put their signature.

National Cleanliness Day

The National Cleanliness Day is widely observed in the state on the birth anniversary of Mahatma Gandhi. Cleanliness is essential for the well being of an individual. Most public places in India, be a street, a government office, railway station, a bus station or a public park looks filthy. The offensive sites of littered garbage, overflowing sewage, defaced walls and water logged areas dot our cities and country. The cleanliness of a city, village or an entire town begins from the cleanliness of individual homes. This responsibility for cleanliness is highlighted by the observation of cleanliness day on 2nd October. The day calls to maintain high standards of cleanliness in our homes, work



places, roads/streets and public places

In the campaign conducted by DISA volunteers, the importance of keeping our surroundings clean in Basti Sadar, Harraiya, and Mithwal Blocks. They explained to the villagers the methods by which they can keep the villages clean.

As a part of the campaign, during the meeting a discussion was held related to a public place. With the consent of all the members such a place was chosen and the cleaning of the same was carried out.

All the members agreed to keep the place clean and hygienic. Thus 23 such public places were cleaned. Besides the common people, volunteers of DISA also participated in the campaign.

Neonatal Week

Newborn health is of paramount importance as this contributes significantly to infant mortality in our country. Infant mortality has significantly dropped over the last one decade, but is still very high. It has reached a plateau which is mainly due to high neonatal mortality rate. Overall, Infant Mortality Rate (IMR) in our country is 70 per 1000 live births, which means out of every 1,000 newborns, 70 die during first year of their life. Two-thirds die in the first month after birth. Of approximately 250 lakh infants born in India every year, 12 lakh die in the first month of life. This is one-fourth of all newborn deaths in the world annually.

Keeping this in mind, under the guidance of DISA, rallies and seminar were conducted in Basti, Harraiya and Mithawal. In the seminar, various symptoms of abnormal body functioning which can endanger the life of new born were discussed. Lips turning blue, bowing of body shape, fever, legs and arms turning yellowish were described and people were made aware to immediately rush to consult a doctor for treatment. Rally was held in the three blocks on 19th November.

HIV/AIDS Day

World AIDS Day, designated on 1 December every year since 1988, is an international day dedicated to raising awareness of the AIDS pandemic caused by the spread of HIV infection and mourning those who have died of the disease. Government and health officials, non-governmental organizations, and individuals around the world observe the day, often with education on AIDS prevention and control. Despite the scientific advancements and laws for protection, people do not know how to



protect themselves and others, and the stigma and discrimination remains a reality for many people living with this condition.

Keeping this in mind, an awareness program was conducted in Basti Sadar, Harraiya, Mithwal and Sahajanwa. Information regarding AIDS is provided, the causes and its preventive measures. The information about the various causes such as contaminated blood transfer, sex with strangers, contaminated needles, syringes, transfer of disease from mother to child during pregnancy etc. were explained. The information regarding the treatment of an AIDS patient was also clearly explained. Students from St. Basil's School, Basti also visited the villages with their awareness program and rally to make the people aware about AIDS. They were made aware that AIDS is not a contagious disease and patient should not be mistreated or avoided. Including all the three blocks, a total of six rallies and seven seminars were conducted.

International Day of Persons with Disabilities, December 03

The annual observance of the International Day of Persons with Disabilities was proclaimed by the United Nations General Assembly resolution 47/3 in 1992. It aims to promote the rights and well-being of persons with disabilities in all spheres of society and development, and to increase awareness of on the situation of persons with disabilities in every aspect of political, social, economic and cultural life.



The main theme for IDPD 2016 was "Achieving 17 Goals for the Future We Want." DISA celebrated the International Day of Persons with Disabilities on 5th December 2016 at Primary School, Bhati Rawat, Shajanwa, Gorakhpur with the support of CBR Forum Bangalore. Almost 60 CwDs and PwDs 200 people from different villages participated in the one day program in which Ms Nidhi Srivastav, Block Ed officer, Sahajawan, was the Chief Guest, Ms Maduri, Head Mistress, Primary School and Mr. Girija Shanker were the main speaker on disability and highlighted the need to bring the PwDs in the main stream. Differently able children from Kasthurba Vidyalaya also took part in the event with their Prayer song. Different types of competitions like, drawing, painting etc... were conducted for the CwDs and Prizes were distributed by Fr. Benny Paul, Program Director, DISA at the end of the program and he gave the message on the importance of celebrating the IDPD and highlighted the five important components of CBR Matrix; Health, Education, Livelihood, Social and Empowerment. Sr. Shiji Kurian, Program officer, Mr. Krishna Kumar, Coordinator, CBR Program, CBR workers participated also supported the CwDs and PwDs to make this event a memorable one.

Human Rights Day

The Human Rights Day (HRD) is observed every year on December 10 to commemorate the Universal Declaration of Human Rights. The declaration was adopted and proclaimed by the General Assembly of the United Nations in 1948 as the shared standard benchmark to protect human rights across the world. The 2016 theme is "Stand up for someone's rights today!", which emphasises on peace and harmony with respect for each other's rights.



Every year, Human Rights Day provides an opportunity for all to renew with the spirit of humanity's long struggle for rights and dignity and to mobilise against old and new challenges, in the shape of poverty and inequality, violence, exclusion and discrimination. As usual, it was celebrated and seminars were held in Basti Sadar, Harraiya, Ikauna and Mithwal Blocks. DISA volunteers enthusiastically organized the celebrations as they were well aware of the human rights violations in countries like India. It was celebrated at 26 places in Basti, 21 places in Mithwal and 19 places in Harraiya. On this occasion, director of DISA, Fr. Benny Paul, volunteers, heads of village, women of BDC, common people and children were present. Altogether three days were spent for the purpose conducting 10 seminars in which 928 people participated. Students from St. Basil's school, Basti also took initiatives to give the idea about Human Rights through their awareness Rally and cultural programs.

Republic Day

Republic day in India is celebrated every year with great honour on 26th of January to honour the Constitution of India as it came into force on the same day in the year 1950. DISA organization took initiative to celebrate Republic Day in Basti Sadar, Harraiya, Ikauna, Shajanwa and Mithwal blocks. The aim of the celebration was to make the rural people familiar with the important national events and bring them to the national main stream. Celebrations were held at 47 places in Basti, 31 places in Harraiya and 23 places at Mithwal. On this occasion Director of DISA, Fr. Benny Paul, and volunteers and heads of villages, along with other people and children were present.

International Women's Day

The 2016 theme for International Women's Day is "Planet 50-50 by 2030: Step It Up for Gender Equality". The United Nations observance on 8 March will reflect on how to accelerate the 2030 Agenda, building momentum for the effective implementation of the new Sustainable Development Goals. It will equally focus on new commitments under UN Women's Step It Up initiative, and other existing commitments on gender equality, women's empowerment and women's human rights.

International Women's Day is a time to reflect on progress made, to call for change and to celebrate acts of courage and determination by ordinary women who have played an extraordinary role in the history of their countries and communities. It is usually organized by the *Nai Disha Mahila Samati*, under the guidance of DISA. The women associated with DISA organization celebrates this day as a festival.



This year the committee decided to celebrate the event in the block level. It was celebrated on 08 March in Basti, 09 March in Harraiya and on 09 March in Mithwal, 08 March in Basti Sadar and 10 March in Ikauna Shrivasti with a large number of women committee members organizing the event. The heads of villages, members of Panchayat and local bodies, and people of the locality were present in large numbers ensuring their contribution and cooperation.

The program chart followed the same everywhere. The program started with the lamp lighting ceremony by the chief guest followed by Prayer song. The women sang songs promoting awakening of women and their education. They also presented dramas with worthy messages. All programs conducted were so touchy and inspiring. The teenagers associated with '*Saloni Sangam*' presented a mesmerizing dance before the crowd. The farmer's club, Self Help Groups and '*Nai Disha Mahila Samati*' office bearers shared their experience. On this occasion the director of DISA, Fr. Benny Paul, Program officer Sr. Shiji Kurian OP, Sr. Arpana SRA and the other volunteers associated with the organization were also present.

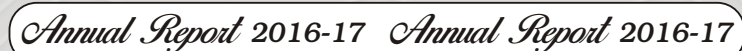
